EXPLANATORY NOTE

Whereas, minors at their tender age should not be exposed to engage in drinking intoxicating liquors and beverages because it is sometimes the cause of trouble and gang war if tolerated;

Whereas; there is a need to regulate the selling and serving of intoxicating drinks among minors to safeguard the youth sector against any violence that maybe created due to intoxication of liquors.

THEREFORE, on motion of Hon. Marlo A. Ligan and duly seconded by Hon. Marjorie C. Jaraula.

BARANGAY ORDINANCE NO. 014
Series of 2019

(INTRODUCED BY: Hon. Marjorie C. Jaraula, Hon. Rosa S. Rapirap, Hon. Mark Anthony A. Botes and Hon. Marlo A. Ligan)

AN ORDINANCE PROHIBITING ALL OPERATORS/OWNERS OF BUSINESS ESTABLISHMENT TO SELL AND SERVE INTOXICATING LIQOURS AND BEVERAGES TO MINORS IN BARANGAY IMBATUG, BAUNGON, BUKIDNON.

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD THAT,

Section 1. All owners/operators of business establishment in barangay Imbatug shall not sell and serve intoxicating liquors and beverages to minors in this barangay.

Section 2. Definition of terms

Minors refers to below 18 years old

Intoxicating liquors – refers to gin, brandy, rhum, tuba, lambanog, and all kinds of wines (tanang ilimnong makahubog)

Beverages – all kinds of beers.

Section 3. Store owners or store attendants shall exercise their best judgment to determine whether their customers are minors or not. If they are in doubt better not to give or demand for proof to determine if the customer is minor or not.

Section 4. Penalty

For store owners/operators

1 st offense	:	reprimand
2 nd offenses	:	a fine of 500.00
3 rd and subsequent offenses	:	a fine of 1,000.00 or no clearance for business permit be issued

For minors and parents

1 st offense	:	reprimand
2 nd offense	:	refer to DSWD for counseling
3 rd and subsequent offenses	:	a fine of 500.00 Pesos

Section 5. Any person who can report with proof of violation of this ordinance with pictures shall be given an incentive of P 300.00 after validation of the report and after payment of the offenses.

Section 6. Verification shall be delegated to either Purok President, Tanod, and Barangay Officials who shall act as witness during the actual violations.

Section 7. The Barangay Treasurer shall collect the fines and issue corresponding receipt hereof.


Section 8. This ordinance shall take effect after review of the Sangguniang Bayan of Baungon, Bukidnon
