**EXPLANATORY NOTE**

**WHEREAS**, Joint Memorandum Circular (JMC) No. 2019-1 of the Department of Interior and Local Government (DILG) and Department of Finance dated May 17, 2019 provide among others, the guidelines for the review adjustment setting and/or adoption of reasonable regulatory fees and charges of Local Government Units,

**WHEREAS**, Under paragraph 6.2 No. 7 thereof, it provides that fees on places of recreation which charge admission fees, the taxing power is now within the barangay concerned; and

**WHEREAS**, In order to implement the provision of the said Joint Memorandum Circular (JMC) No. 2019-1, hence, this ordinance.

**THEREFORE**, on motion of Hon. Marlo A. Ligan and duly seconded by severally

**BE IT RESOLVED AS**, this council hereby resolved, to enact:

**BARANGAY ORDINANCE NO. 2019 -018**  
**(INTRODUCED BY: ALL SANGGUNIANG BARANGAY MEMBERS)**

**AN ORDINANCE IMPOSING FEES ON PLACES OF RECREATION WHICH  
CHARGE ADMISSION FEES**

Be it ordained, by this council in session, held that:

**Section 1.** This Ordinance authorizes the collection of fees on places of recreation which charges admission fees.

**Section 2.** Places of Recreation includes – inland resort club house, parks, swimming pools, tennis court, trails and similar facilities.

**Section 3.** Imposition of fees- a charge of P 1.00 per person admitted on the recreational facility shall be collected as levy on the admission fees imposed by the facility operator.

**Section 4. Administrative Provisions;**

a. All persons who will be admitted to the recreational facility shall register their names and other information on the record book kept for the purpose as provided by the operator at the entrance of the establishment.

b. Operators shall maintain the daily record of their customer/guest and shall be open for inspection during the usual office hours or operating hours.

**Section 5. Manner of Collection of fees levied:**

At the end of every month the operator of the recreational facility shall pay to the Barangay Treasurer the amount accrued to the Barangay Government on the basis of the registered guests.

(The One Pesos (P 1.00) charge upon agreement with the operator and the Barangay Government maybe an add on to the entrance fee or whatever be the pleasure of the both parties)

**Section 6.** The Barangay Treasurer is authorized to collect payments from the operator and issue corresponding receipts thereof.

**Section 7.** The amount collected shall accrue to the general fund of the Barangay.


**Section 8.** This ordinance shall take effect after the review of the Sangguniang Bayan of Baungon, Bukidnon.

**Section 9. Penalty** – Facility Operator who violates any provision of this Ordinance shall be fined P 1,000.00


