EXPLANATORY NOTE

WHEREAS, this Ordinance was imposed to preserve and protect the landmark/signage in every Purok within Barangay Imbatug.

WHEREAS, the said ordinance is strictly impose for the community to give value of the said purok projects though the efforts and support of the Barangay Government as well as the constituents within the puroks.

WHEREAS, to protect, maintain and preserve the improvements made on LANDMARKS/SIGNAGE vandalism, dumping of garbage, destroying of the structure, as well as tying of animals within the premises is PROHIBITED.

WHEREFORE, on motion of Hon. Arcelie P. Bodiongan and duly seconded severally. Be it resolved, as this council hereby resolved to enact.

**BARANGAY ORDINANCE NO.: 2016-02
(INTRODUCED BY HON. ARCELIE P. BODIONGAN)**

ORDINANCE FOR THE PROTECTION AND PRESERVATION OF LANDMARKS AND SIGNAGE, IN ALL PUBLIC AREA ESPECIFICALLY FOR BARANGAY IMBATUG AS WELL AS PROHIBITING CERTAIN ACTS AND IMPOSING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF BARANGAY IMBATUG IN SESSION ASSEMBLED HELD ON JULY 19, 2016 THAT:

SECTION 1. PROHIBITED ACTS.

The following act are hereby declared illegal and strictly prohibited.

1. Dumping garbage on the Landmarks or Signage-premises
2. Vandalism or destroying the landmark and signage.
3. Tied up animals on the landmark or signage premises.
4. Drinking of liquors in the landmarks/signage premises.

SECTION 2.

Any person in authority or agents of persons in authority, like the Police, Punong Barangay, Barangay officials, Barangay Tanods and Volunteers are authorized to report or bring the person or owner of the animals, who violate to the said ordinance to the nearest officials of the Barangay as the case maybe, for record purposes, for safe keeping and prosecution.

SECTION 3. PENALTY

Failure on the part of the individual member of household of each purok to comply the ordinance will be punished with a fine of:

- a.) 1 offense-reprimand
- b.) 2nd offense-1 day cleaning of the area, including planting of flowers within the area for beautification.
- c.) 3 offense-P1000.00

Or succeeding offenses or upon imprisonment of not less than 3 days but not to exceed 5 days or both FINE and imprisonment at the discretion of the katarungan Pambarangay.

SECTION 5. The Barangay Treasurer is authorized to collect these fines and issue official receipts for payment made and money shall accrue to the General Fund of the Barangay.


SECTION 6. Any person who refuses to pay the Fines herein imposed, shall be prosecuted or be settled in the Barangay Justice by the Punong Barangay.

SECTION 7. That the copy of this Ordinance be furnished to the Office of the Sangguniang Bayan for review and be posted to Three (3) conspicuous places for information and guidance of the constituent concern.


