**EXPLANATORY NOTE**

**WHEREAS;** this proposed Ordinance was purposely enacted by the Barangay Council of Imbatug for legality of the Barangay collection fee specifically the renting fees for all Barangay owned facilities.

**THEREFORE,** on motion of Hon. Marifel L. Palma and duly seconded severally.

**BE IT RESOLVED** as this council hereby resolved to enact;

**ORDINANCE NO. 06 SERIES OF 2017  
(INTRODUCED BY:HON. MARIFEL L. PALMA)**

**“AN ORDINANCE IMPOSING FEES AND CHARGES OF BARANGAY OWNED FACILITIES.**

**BE IT ORDAINED, by this Council in session held that:**

**SECTION I** This ordinance, shall prescribed the use of the Barangay Hall Building, thru rental by private firm, corporation, institution and individual and to whatever purpose it may deemed served to its best.

**SECTION II SCOPE OF APPLICATION**

This Ordinance, shall govern the use of the Barangay Hall Building on the following scheme.

1. For holding of meetings, conferences, symposium, forum and whatever gathering to be held in its premises, the following rates of fees or rental per day is as follows:
  - a. P 1,000.00 per day, inclusive all facilities.
  - b. Rental for monoblocks chairs & tables for birthdays, weddings and special gathering P 500.00 per day.

**SECTION III- LIABILITIES OF THE USES**


Any damage incurred, inside the Barangay Hall Building shall be shouldered by the users. These renting outside the hall any damage to chairs and tables shall be paid according to its purchase price, losses monoblocks chairs shall be accounted to its users and shall be paid accordingly.

**SECTION IV- COLLECTION** – The income derived there from shall accrue to accounts of the Barangay with corresponding receipts issued to and users.

**SECTION V- SEPARABILITY CLAUSE**-Should any portion of this Ordinance be declared unconstitutional or illegal by any court of competent jurisdiction the portion not so declared shall remain in full force and effect.

**SECTION VI- EFFECTIVITY**- This Ordinance shall take effect after the review of the Sangguniang Bayan.
