WHEREAS, it is necessary to define the limited functions of the Officer of the Day in order to sustain the harmonious implementation of laws and regulations in the absence of the Punong Barangay.

BARANGAY ORDINANCE NO. 04
SERIES OF 2018
(INTRODUCED BY: HON. MARJORIE C. JARAULA)

**AN ORDINANCE DEFINING THE LIMITED FUNCTIONS OF THE SANGGUNIANG
BARANGAY MEMBER WHILE ACTING AS OFFICER OF THE DAY**

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD, THAT:

SECTION 1. A Sangguniang Barangay Member or Barangay Kagawad acting as Officer of the Day is vested with the authority to sign documents in the absence of the Punong Barangay.

SECTION 2. The documents which the Officer of the Day can sign are as follows:

- a. Certificate of Residency
- b. Certificate of Indigency
- c. Certificate of Business Location
- d. Clearance for Employment and Loan Purposes

SECTION 3. In case of the officer of the day do not personally know the person he/she is certifying to, he/she will not be compelled to sign the certification unless a proof from the Purok Officials where he/she reside will be presented as a proof.

SECTION 4. All other documents secured from the Barangay, aside from those mentioned above shall need the signature of the Punong Barangay, hence, the Officer of the Day are not authorized to sign in behalf of the Punong Barangay.

SECTION 5. Officer of the Day who violated this ordinance shall be liable for any administrative sanctions in case there will be problems that may be encountered in the future.


SECTION 6. This Ordinance shall take effect after the review of the Sangguniang Bayan of Baungon, Bukidnon.

BARANGAY ORDINANCE NO. 05
SERIES OF 2018
(INTRODUCED BY: HON. MARJORIE C. JARAULA)

AN ORDINANCE IMPOSING PENALTIES TO ANY PERSON OR GROUP OF PERSONS WHO WILL PLACE THEIR ADVERTISEMENT THROUGH SIGNBOARDS OR BILLBOARDS, AND ANY OTHER MATERIALS USED AS

ADVERTISEMENT ON ALL TREES ALONG THE ROADS AND PUBLIC PLACES OF BARANGAY IMBATUG, BAUNGON, BUKIDNON.

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD THAT,

SECTION 1. Administrative Provision. No person shall place advertisement through signboards or billboards and any form of materials in all trees along the roads and public places within this Barangay.

SECTION 2. A person caught in the act of posting the advertisement or a picture showing the actual placement of the signboards with the person concerned, are enough evidence which will warrant the imposition of penalties in violation of this ordinance.

SECTION 3. Penalties, any person caught in the act violating this ordinance shall be penalized as follows;

First Offense -----fine of P 500.00
2nd and Subsequent Offenses -----fine of P 1, 000.00

SECTION 4. The Barangay Treasurer is authorized to collect penalties for violations of this ordinance and issue official receipt thereof.


SECTION 5. This Ordinance shall take effect after review of the Sangguniang Bayan of Baungon, Bukidnon.

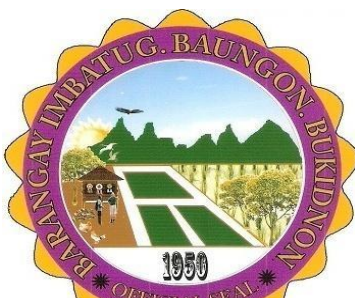

WHEREAS, it is necessary that all person or group of persons conducting selling or product presentations and other activities within the barangay shall secure clearance first from the Punong Barangay.

THEREFORE, on motion of Hon. Marlo A. Ligan and seconded severally.

BE IT RESOLVED, as this council hereby resolved, to enact;

BARANGAY ORDINANCE NO.06
SERIES OF 2018
(INTRODUCED BY: HON. MARJORIE C. JARAULA)

AN ORDINANCE REQUIRING ALL PERSONS CONDUCTING SELLING OR PRODUCT PRESENTATIONS AND ANY OTHER ACTIVITIES WITHIN THE BARANGAY TO SECURE CLEARANCE FROM THE PUNONG BARANGAY BEFORE CONDUCTING THEIR ACTIVITIES.

BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD, THAT:

SECTION 1. All persons conducting selling or product presentations and any other activities either house to house selling or going to schools and other institutions within the barangay, shall secure Barangay Clearance prior to the holding of their activities.

SECTION 2. Administrative Provision. Vital informations about the company or entity shall be properly documented in the barangay for reference purposes.

SECTION 3. Corresponding clearance fee shall be collected in accordance with the existing ordinance of the barangay.

SECTION 4. If the venue of the product presentation is owned by the barangay as well as the facilities to be used, payment for using the venue and facilities will be collected, consistent with Barangay Ordinance.

SECTION 5. EXEMPTION: Sponsoring groups or entities during special events hosted by the Government is exempted in the provision of this Ordinance.

SECTION 6. The Barangay Treasurer is authorized to collect fees and issue corresponding receipt thereof.

SECTION 7. Penalty.

1st Offense -----fine of P 500. 00

2nd and Subsequent Offenses -----fine of P 1, 000.00

SECTION 8. Effectivity.


