**BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELD, THAT:**

1 <sup>st</sup> Offense	-	a fine of P 500.00
2 <sup>nd</sup> and Subsequent Offenses	-	a fine of 1,000.00

SECTION 5. This ordinance shall take effect after review of the Sangguniang Bayan of Baungon Bukidnon.



**EXPLANATORY NOTE**

**WHEREAS**, rugby and vulca seal are among the popular known inhalants that caused addiction when abused specially to minors;

**WHEREAS**, the case of inhalants addiction is already alarming among school children in this level when volume of empty plastic bags containing residues of rugby and vulca seal were recovered on some areas within the barangay only few meters away from school campuses;

**WHEREAS**, there is a need to regulate the selling of said health hazard sealants specially to minors because they might be tempted of using and/or they will be addicted in inhaling it.

**BARANGAY ORDINANCE NO. 08  
SERIES OF 2018  
(INTRODUCED BY: HON. MARJORIE C. JARAULA)**

**AN ORDINANCE REGULATING THE SALE OF RUGBY AND VULCA SEAL AMONG MINORS IN ALL BUSINESS ESTABLISHMENTS WITHIN THE TERRITORIAL JURISDICTION OF IMBATUG, BAUNGON, BUKIDNON AND IMPOSING PENALTIES FOR VIOLATIONS THEREOF**

**BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELDTHAT,**

**SECTION 1.** All business establishments thru their respective owners or operators shall not sell rugby and vulca seal to minors.

**SECTION 2. DEFINITION OF TERMS**

Minors – refers to below 18 years old

Rugby – is a sealant with a very offensive smell usually used to fix worn out materials

Vulca Seal – is a sealant used to seal or patch holes especially on roofing's.

**SECTION 3.** Business operators/owners shall exercise their best judgment to determine whether their customer is minor or not, if in doubt better not to give the items.

**SECTION 4. Penalties for business operators/owners**

1<sup>st</sup> offense -----a fine of P 500.00

2<sup>nd</sup> offense -----a fine of 1,000.00

3<sup>rd</sup>and subsequent offenses      No Clearance shall be issued to business establishment

**SECTION 5.** Any person who is instrumental on the apprehension of violators of this ordinance shall receive P 300.00 as incentives fee, subject to usual accounting and auditing procedures.

**SECTION 6.** The barangay treasurer is authorized to collect the fines and the amount collected shall accrue to the trust fund of the barangay and be used solely for peace and order activities.

**SECTION 7.** This ordinance shall take effect after review of the Sangguniang Bayan of Baungon, Bukidnon.



**WHEREAS**, considering the increasing cost of office supplies and other related expenses in the preparation of documents there is a need to fix an amount that will be collected from the person who will request for the making of agreement (Kasabutan) in the Barangay Hall.

**BARANGAY ORDINANCE NO. 09**  
**SERIES OF 2018**  
**(INTRODUCED BY: HON. MARJORIE C. JARAULA AND HON. ROSA S. RAPIRAP)**

**AN ORDINANCE IMPOSING CHARGES ON EVERY AGREEMENT RELATED TO MORTGAGE, SELLING, AND RENTALS OF PROPERTIES AND OTHER AGREEMENTS MADE IN THE BARANGAY HALL OF IMBATUG, BAUNGON, BUKIDNON.**

**BE IT ORDAINED, BY THIS COUNCIL IN SESSION HELDTHAT,**

**SECTION 1.** All transactions which will be brought to the barangay hall for making agreements (kasabutan) which involves an amount of money shall be subject to the collection of fees and charges.

**SECTION 2.** Requirements for making the agreement shall be community tax for both parties and photo copy of the Tax Declaration or Title of the subject property, if it involves real properties.

**SECTION 3.** For mortgage, selling and rentals of properties the amount to be collected are as follows.



P 1.00	- 10,000.00	- P 100.00
10,001.00	- 50,000.00	- P 200.00
50,001.00	- 200,000.00	- P 300.00
200,001.00	- 500,000.00	- P 500.00
Over	- 500,000.00	- P 1,000.00

**SECTION 4.** The Barangay Treasurer is authorized to collect the amount and to issue corresponding receipts thereof.

**SECTION 5.** This ordinance shall take effect after review of the Sangguniang Bayan of Baungon, Bukidnon.
